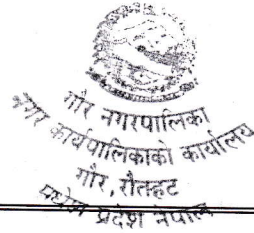

# Invitation for Bids

1. Office of the Municipal Executive, Gaur Municipality, Rautahat invites electronic bids from eligible bidders for the construction of Fabrication, Supply, Transportation, Construction and Erection of Baneshwor Nathmandir Trail Bridge, Gaur-2 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures on Lump- sum contract.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Minimum average annual construction turnover of NRs 3,83,00,000/-calculated as total certified payments received for construction contracts in progress or Completed, within best three years out of last ten years.

Only the net amount shall be calculated after deducting the amount for VAT and such amount shall be adjusted wholesale price index of Nepal Rastra Bank.

For Single Entity: Must meet requirement

For joint Venture: All combined partner must meet requirements, Each partner Must meet...25%...of the requirement, One partner must meet. 40%. Of the requirements.

Documents Submission Requirements: Form FIN -2

Minimum Work experience of similar size and nature:

- a. Participation as Prime contractor, management contractor, or subcontractor, in at least Two(2) Trail Bridge of within the last ten (10) years, with a value of each NRs 1,55,20,000/-that have been successfully or are substantially completed and that are similar to the proposed works.
- b. Participation as Prime contractor, management contractor, or subcontractor, in at least one(1) Suspension ( N) Type Trail Bridge with Span of at least 210m with a value of 2,29,80,000. With in the last ten(10) years, that have been completed greater than or equal to 80 % Progress.

The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.

Each partner: at least one Contract within the last ten (10) years with a value of at least NRs 28, 30,000/-that have been successfully or are substantially completed and that are similar to the proposed works

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other(ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
